## Important Medical Information

### **ATTENTION PARENTS!**

Please read the following sections carefully as they pertain to all HMI Christian Hockey Camps campers.

### **CAMPER HEALTH INFORMATION FORM AND OVER THE COUNTER MEDICATION FORMS:**

If your child has a medical condition/injury or has medication(s) that need to be dispensed during the week of camp, you **MUST** have a physician review & sign the **Camper Health Information Form** after your child has a physical examination by the physician. The physician should indicate any restrictions from activities at camp.

If your child has no medical condition/injury and does not take prescribed medication, you (the parent/guardian) may choose to check the box in Part B, giving consent in place of the Physician, although, it is still highly recommended that your child have a physical examination prior to camp.

Parent/guardian must also complete the **Over the Counter Medication Permission Form**.

### **MEDICATIONS**

If your child will be taking medication during camp, you must turn in **ALL** medications in their original containers to the camp nurse at camper registration. The physician's orders and/or instructions must be marked on the label. Please write your child's name on top of the bottle(s) or container(s) in black marker. **Sorry, we cannot accept daily pill dispensers with mixed medications in them.**

**Absolutely no medication can be kept in camper rooms. (exceptions: Asthma inhaler, Epi-Pen)**

The camp has a limited stock of over-the-counter medications available to your child, if necessary. In all cases, these medications cannot be dispensed unless you hand in your signed **OVER-THE-COUNTER-MEDICATION PERMISSION FORM** to the camp nurse.

**HEAD INJURIES:** Campers with previous head injuries must have a medical Dr's written permission to play again and/or participate at camp. This must be presented to the camp medical staff upon arrival.

### **MEDICAL STATION (DURING REGISTRATION AT CAMP)**

**ALL** campers must stop at the medical station to turn in their health forms. Without the Camper Health Information Form on site at camp, your child will not be allowed to participate at camp. If your child has a medical condition or is taking medication, you **MUST** speak to the camp nurse to explain your child's needs and/or medication schedule. **AGAIN**, for the **SAFETY** of everyone at camp, **CAMPERS CANNOT KEEP ANY MEDICATIONS IN THEIR DORM ROOMS.** (Exceptions: Asthma inhaler, Epi-Pen). We are committed to providing a fun and safe environment for all campers. We have medical staff available 24 hours / day including nurses and trainers that are at the rink during ice times. In case of emergencies, we have access to an Urgent Care Clinic or Hospital.

**WE HAVE A ZERO TOLERANCE POLICY FOR DRUG ABUSE, TOBACCO OR ALCOHO AT CAMP.**

### **OUT-OF-COUNTRY COVERAGE**

It is the responsibility of the parent/guardian to confirm out-of-country medical coverage, if applicable.
